

Auto Maintenance Corner

Along with turning leaves and trick-or-treaters, there are other, more frustrating signs of the season's change, including frosted windshields, chilly morning commutes, and slick spots on the road. Take advantage of the waning warm days to pop the get under the hood and prep your car for the colder months. With each season's change, it's a good idea to schedule your vehicle for its routine maintenance like an oil and filter change.

The first significant snowfall of the year always catches us by surprise, but be ready for it by swapping out lighter spring wipers for heavier, insulated wipers. Make sure that your anti-freeze is fairly fresh. If you've used water in the radiator over the summer, it's a good idea to swap out your coolant for fresh. Also, take your vehicle to a local auto parts store and have them check your battery. This service is typically free and will let you know what kind of life you have left in your battery instead of coming out of a movie theater on a frigid night to find a dead car.

Consider purchasing winter tires or swapping out summer performance tires for something better equipped to deal with ice & snow, like a good all-weather tire. Be sure to match your vehicles speed rating to the appropriate tire.

Scraping the windshield can be a pain, so give yourself a shortcut using household items. Save and rinse out your next two plastic milk jugs. When clean, fill with water and place in the garage. The next time the windshield and windows are frosted, pour the water over the glass then quickly run the wipers to clear away the excess. It's important to keep the filled jugs in the garage or a cool place over night. DO NOT use hot water as it can cause

the glass to crack. This is a quick and easy way to clear your glass of frost. It beats cycling through gallon after gallon of windshield washer fluid. Speaking of which, keep your washer fluid topped off with fluid that stays liquid down to at least -20 degrees. This will prevent your washer and fluid lines from freezing and becoming inoperable at high speeds on cold days.

Colorado is a state where year-round motorcycle riding is popular. Just because you might not want to be out in the cold, doesn't mean that other motorcyclists won't be, so please keep an eye out for our two-wheeled friends. If you do brave the winter to stay on two, monitor the weather conditions before your rides. Be aware that melting snow quickly turns to dangerous black ice on cold streets. Opt for anti-fog protection for helmet visors as some helmets are known to fog up at low temperatures.

For those putting away everything from motorcycles to cars, to lawn mowers over the winter, be sure to drain the gasoline from tanks and carburetors prior to storing. Replace gasoline with an inactive agent such as Stabil to keep water from building up in the tank and causing rust. Place batteries on trickle chargers to extend their life and move your vehicle every few weeks, if possible, to avoid creating flat spots in the tires.

As always consult your mechanic regarding any automotive questions or concerns. It's always better off to find out about a potential problem while you can still fix it instead of when it's too late and you're stranded.

Tips if you would like to do it yourself:

1. Know where your main shut off is, usually a yellow or red lever where main **water source** comes in to home. (Know the source of water problem: Ground seepage not covered by insurance. Washer hose or broken pipe covered by insurance, read your policy.)
2. Remove all free standing furniture from affected areas or place a barrier between any metal or wood furniture, using pine blocks or styrofoam, to prevent furniture stain on carpet.
3. Extract excess moisture and pull carpet corners back.
4. Set funnel fan between carpet and pad so it floats. **(Air movement.)** Stagnant air produces bacteria. Molds only grow if they have a moisture source. **Drying and air movement are key steps.**
5. Anti-bacterial spray (call a professional.)

Holiday Safety Tips

Arapahoe County Sheriff

Below are some helpful safety tips for this holiday season.

Before You Shop:

- Avoid carrying a purse if possible. Wear clothing with deep pockets to carry only what you need.
- Avoid carrying large amounts of cash. Pay for purchases with a credit card or debit card when possible. Remember though, that it is easier to dispute a charge on a credit card than a debit card.
- Be extremely careful using ATM machines. Only use them in populated places, and pay attention to what's going on around you. If an ATM or similar device appears to be tampered with, DO NOT attempt to use it.
- Teach children to go to a store clerk or security guard and ask for help if they become separated from you. They should never go into the parking lot alone.

While Shopping

- If you have to carry a purse, carry it close to your body and always keep it zipped. Do not put it in a shopping cart.
- Park your vehicle as close to the mall as possible. Attempt to park in well-lit areas.
- Know exactly where you park your car. Make a mental note or write it down, so you will know exactly where to go when you leave the mall.
- Leave the mall well before closing time. This way, you are sure to walk out with other people. Remember there is safety in numbers.
- Avoid shopping when you are exhausted. You are more alert when you are less tired.
- When in a hurry, make sure you get all forms of identification and credit cards returned to you before leaving.
- Mall security can escort you to your car upon request if you have a lot of packages or if you are leaving the mall after closing.
- When leaving, be aware of your surroundings. When approaching your car, look around, underneath and inside your car for anything suspicious. Hiding in the parking lot is a common practice for criminals, and they will take you by surprise.
- When leaving, have your keys in your hand and ready to use.
- Keep your packages stored out of sight in the trunk of your car.
- Periodically, take packages out to your car but be aware that criminals watch for people who place packages in vehicles and return to the mall. To combat this, move your vehicle to another area of the mall to give the appearance that you are leaving.

At Home

- Keep gifts hidden from view through outside windows.
- After opening gifts, break down cardboard boxes of expensive electronics and fancy stores and put them in plastic bags to hide the fact you have valuable items in your home.
- Be extra cautious about locking doors and windows when you leave your house or apartment, even for a few minutes.
- Be wary of solicitations for charitable donations. Criminals may attempt to take advantage of people's generosity during the holidays. Always ask for identification, how donated funds are used and if contributions are tax deductible. If you are suspicious about someone's behavior, contact the Arapahoe County Sheriff's Office, or your local law enforcement agency.

Winter Preparedness Tips

From the City of Centennial

With winter just around the corner, it is important time to plan for the hazards and dangers of the winter season. Below are some safety tips to help you prepare for the coming winter:

BEFORE the storm

- Service snow removal equipment, have rock salt on hand to melt ice on walkways, and kitty litter to generate temporary traction.
- Be familiar with winter storm warning messages.
- Make sure you have sufficient heating fuel available in case regular fuel sources are cut off.

Winterize your home

- Insulate walls and attics.
- Caulk and weather-strip doors and windows.
- Install storm windows or cover windows w/ plastic from the inside.

Have safe emergency heating equipment available

- If you have a fireplace, ensure there is an ample supply of wood.
- A small, well-vented, wood, coal, or camp stove with fuel.
- Portable space heaters. (Kerosene Heaters: Check with your local fire department on the legality of using kerosene heaters in your community. Use only the correct fuel for your unit and follow the manufacturer's instructions. Refuel outdoors only, and only when cool. Keep your kerosene heater at least three feet away from furniture and other flammable objects.)

Keep pipes from freezing

- Wrap pipes in insulation, or layers of old newspapers.
- Cover the newspapers with plastic to keep out moisture.
- Let faucets drip a little to avoid freezing.
- Know how to shut off water valves.
