This year five seats on the nine-member City Council are up for election. Centennial voters will elect a Mayor and a Council Member from each of the four Districts on November 5, 2013. The City of Centennial is divided into four Districts. Each District is represented by two City Council Members that serve four year staggered terms, along with the Mayor who is elected at-large. Ballots will be mailed to all voters October 15-18. Voters may drop off ballots at the Centennial Civic Center October 15 through November 5. The Centennial Civic Center will be open Saturday, November 2 from 9 a.m. to 3 p.m. to receive drop off ballot. Drop off sites are open 7 a.m. to 7 p.m. on Election Day, November 5. ### **Drought Watering** Restrictions

For properties that are damaged and remain damaged on January 1, 2014, the Assessor's Office may make adjustments to the value for Tax Year 2014 after being notified and conducting an inspection. ### LPS Bond Issue 3B

This November there will be a Bond Issue on the ballot for Littleton Public Schools. The District school buildings range from 32-93 years in age - the average building is more than 50 years old – so as you can imagine, many are in need of update and repair. A task force has done extensive research and determined the necessities to keep our schools standing, safe, and altogether the great learning environments we have enjoyed since the District's inception. There are several links at www.littletonpublicschools.net that will give you more information about the process and specific needs for each building.

The data is well organized and the work the task force has done is impressive. They have done everything possible to pare down the list to absolute priorities. For example, Littleton High School has a boiler that was installed in the mid-1950s. The manufacturer went out of business in 2002, so there are no longer replacement parts available. The greatest areas of need district-wide are: upgrading heating and ventilation systems, including replacement of original boilers; repairing and improving power and electrical equipment; replacing failing roofing; repairing or upgrading fire alarms and fire sprinkler systems; repairing and replacing inefficient lighting; repairing deficient plumbing; updating wireless access points and improving technology infrastructure to support science, technology, engineering and math programs.

The best part of the Bond issue is there will be NO tax increase. The money will come from refinancing existing bonds to a lower interest rate (similar to refinancing your home) to accommodate the issue of new bonds, which requires voter approval. According to an article that was published in "The Villager" on 9/18 by Tom Barry, "To date, there is no active organized opposition" to the Bond Issue.

As we all know, our property values are largely contingent upon the quality of our school district. An investment into LPS infrastructure is akin to an investment in your own property. Please help ensure LPS can continue its primary focus on excellence in education by voting YES on Bond Issue 3B.

### Southglenn Sustainability Bike Tour

This inaugural event was held at the end of August with about 10 participants (hard to count because several kids joined us or left us mid-tour). We began our tour visiting the gardens of a Franklin Circle resident. He has implemented various gardening techniques such as companion planting and hugelkultur. Used for centuries in Eastern Europe and Germany, hugelkultur (in German hugelkultur translates roughly as "mound culture") is a gardening and farming technique whereby woody debris (fallen branches and/or logs) are used

as a resource. Logs are either stacked, or in this resident's yard, buried under soil and amendments. Hugelkultur garden beds help retain moisture on site, build soil fertility, improve drainage, and use woody debris that is unsuitable for other use. Urban lots with compacted soils, areas with poor drainage, limited moisture, etc., can be significantly improved using a hugelkultur technique, as hugelkultur beds are, essentially, large, layered compost piles covered with a growing medium into which a garden is planted.

Next an Easter Circle resident gave us an overview on beekeeping and donned her beekeepers veil to show us the inner-workings of one of her beehives. We discussed the different responsibilities of various bees in the hive, what causes bees to swarm, the importance of bees on our food supply, and various other bee-related topics.

Our third stop on Clarkson Street allowed us to see high-yield, densely planted square foot garden in action. Additionally she had converted a cooktop stove found on Craigslist to propane, set it into a countertop offered on FreeCycle, which she used as an outdoor canning operation. This helps to keep the heat out of her kitchen on those hot, late summer days when preserving crops are at their peak. This stop also was home to half-a-dozen chickens whose residence was built primarily out of recycled fencing slats

and materials. Even though city ordinances were only changed last summer to allow for up to 6 chickens, with the use of the reclaimed materials the coop and run looked like it had been there for decades.

Next on the route was a quick lesson on how to brew and bottle beer at home. The complex art of brewing beer was presented in a simple and straightforward manner, with

explanations of how the timing of ingredient additions and the length of exposure to them results in very different flavored brews. The sample of the batch bottled earlier that day was delicious!

### Tips if you would like to do it yourself:

- Know where your main shut off is, usually a yellow or red lever where main water source comes in to home. (Know the source of water problem: Ground seepage not covered by insurance. Washer hose or broken pipe covered by insurance, read your policy.)
- Remove all free standing furniture from affected areas or place a barrier between any metal or wood furniture, using pine blocks or styrofoam, to prevent furniture stain on carpet.
- 3. Extract excess moisture and pull carpet corners back.
- 4. Set funnel fan between carpet and pad so it floats. (Air movement.) Stagnant air produces bacteria. Molds only grow if they have a moisture source. Drying and air movement are key steps.
- 5. Anti-bacterial spray (call a professional.)

Finally we visited a residence that implements many components of sustainability. Primarily it is a ranch residence that houses 6 people. One occupant has commuted on his bike to work nearly everyday for many years. One of the vehicles is electric. The house has several skylights to reduce the need of supplementary electrical lighting. It is cooled with an evaporative cooler, which is much more efficient than air conditioning. They have bees and quite a number of hives (at friends' and family's houses as well) for honey collection, an impressive garden, fruit trees, and chickens. They also have solar panels that they lease that has allowed them to "fix" their electric costs (Public Service still wants to be paid for their electric infrastructure, whether it is used or not) into the foreseeable future, while allowing them to be somewhat energy independent with regard to electric. The tour was very inspiring. While all participants strive to be more sustainable, we admit that total self-sufficiency is neither practical nor necessarily desirable. We all just wish to tread more lightly on the planet, reduce our carbon footprint, waste less, and make more out of what we have. We have some ideas for how this tour might be expanded or modified next year. We hope more will join us!

The district currently instructs 15,350 students. The age of the structures for the district varies from 32 to 93 years old. The average building is more than 50 years old. The review of the district's physical structures was initiated nearly two years ago and the citizens' Capital Improvement Planning Committee and district consultants began the extensive undertaking last spring. The 3B campaign website features a detailed summary of what is needed and what would be repaired at each school and other district structures. LPS has 24 structures, all in need of varying levels of repairs primarily related to roofs, electrical systems, ventilation systems, plumbing, lighting, fire alarms, and technology infrastructure. In refinancing its bonds in 2010, LPS was able to reduce its interest rate to 2.9 percent – a drop from the earlier 5.2 percent. Those bonds are scheduled to be paid off in 10 years. With current low rates, this bond issue allows LPS to borrow more money for building maintenance without taxpayers paying a higher mill levy. The mill levy will remain the same. If the bond issue does not pass, the current mill levy rate will drop when the current debt is paid off. The school board has decided to go to the voters now due to the low interest rates.

City of Centennial Ballot Question 2G

The ballot question relates to the City's ability to use its existing fiber optic infrastructure. The City has developed a backbone of more than 40 miles of fiber optic infrastructure in many City streets to operate the City's traffic control signals, weather stations and to connect public facilities. This infrastructure has improved traffic flow and reduced congestion within the City's transportation system. Thanks to improvements in technology, these fiber optic lines could now also be used in partnership with private broadband service providers to facilitate access to advanced telecommunications and Internet services. This service, gigabit internet, is highly desired by libraries, schools, and the medical community. Current internet speeds are much slower than what a fiber optic option could bring.

In 2005, Senate Bill (SB) 05-152 passed prohibiting all local governments from directly or indirectly providing telecommunications services to their residents and businesses. SB 05-152 prevents municipal competition against the private sector in the delivery of telecommunications and related services unless voter approval is obtained. The ballet language does not allow the City to form an internet utility, but requires partnering with companies to do this.

The Colorado Amendment 66 would raise a projected total of \$950 million for funding public education by increasing the state's income tax rate. The measure would also allow for the implementation of the new Public School Finance Act Senate Bill 213. Colorado Commits to Kids is sponsoring the initiative. The state's current personal income tax rate is a flat 4.63%.[4]

Amendment 66 would implement a two-step state income-tax rate increase detailed as follows:

Step 1: Increase the rate on taxable income up to \$75,000 to 5%. Step 2: Tax any income above \$75,000 at 5.9%.

The Colorado Funding for Public Schools Initiative is part of larger effort by various groups and legislators to overhaul the state's public education system. It should be noted that the ballot imitative is related to, but separate from, SB 213. The bill is an amendment to the Colorado Public School Finance Act that affects how the state finances individual schools, not how the state education system itself is funded. That task is left to the initiative which seeks to raise taxes for funding the legislation. There is a clause built into SB 213 that prevents it from taking effect unless the initiative is passed in November.
