UPDATE ON THE STREETS AT SOUTHGLENN REDEVELOPMENT

Neighbors for The Streets at SouthGlenn (N4S@SG)

Most of the N4S@SG steering committee of 12 met (remotely) with the developers and their design team the week of April 13. We were presented with the latest iteration of how the developers want to redevelop the Sears property, and therefore the rezoning request that they want to make to the City of Centennial.

The second traffic count was turned into the city last week. In summary, the 2nd count (done Feb 27th at 15 site intersections) basically shows the same count as the first count that was done last summer for all of the same intersections. Therefore, no additional mitigation or changes are coming related to traffic. There are still issues – especially with cut-through traffic affecting intersections that were not studied – and we'll have to work with our elected officials to get those needs addressed.

The redevelopment does plan to move the access points into S@SG to ease existing traffic issues/congestion along Easter Ave. Specifically, to those in front of the Glen Oaks Townhomes and Glen Oaks Condos driveways. Also, we've asked for a light and crosswalk to serve those in wheelchairs and slower walkers who live in the condos and townhomes.

We asked for more open space/park area, and they are willing to build more; approx. .75 acre, which is roughly the same size as the current Commons park in the center of the S@SG where summer concerts are held. The details of what that looks like will come later.

We asked for no more than 4 stories to keep the building around 50' high. We're trying to protect sight-lines to mountain views, and not create a concrete tunnel along Easter Ave. They are willing to limit some building heights to 50' along Easter, but not the entire building.

The distance from the street curb to the side of any building is the setback. We asked for more, and they showed us that they are willing to do more. The setback distance varies depending on where you are on the big Sears parcel.

Most importantly, we asked for fewer apartment units to reduce how much "urban" feel is being introduced into our suburban neighborhood. They are not willing to go below 550 units.

Over the past year, there has been progress in meetings and sharing of ideas. The developers have made some changes and have been sincere in their efforts. They have been collegial and mostly open to hearing what is important to us.

The next step up to the developers who plan to come back to us soon. If they decide to move forward with a rezoning request to match what they have presented to us, we'll need to decide how to react, because we're not on the same page.

Bottom line – we are opposed to rezoning to allow buildings taller than four stories (52') along Easter Ave and density over 35 dwelling unit/acre (which equates to more than 410 rental units on the Sears site).

We think it is likely they will present a proposal to the City of Centennial in May. Stay tuned and be ready to react quickly! Your help will be needed!

Colorado Enterprise Fund and the City of Centennial Partner to Launch Centennial Small Business Loan Fund

Colorado Enterprise Fund (CEF), in partnership with the City of Centennial, has created the Centennial Small Business Loan Fund to help small businesses in Centennial access capital and business coaching.
