SOUTHGLENN IS SWINGIEST SWING DISTRICT IN SWING STATE

Our neighborhood has the lucky distinction to be home to three different districts that during the 2016 election voted for Hillary Clinton for President, but that elected Republicans for other offices. In 2014 Democratic Governor John Hickenlooper beat Republican Bob Beauprez here. In 2012 Mitt Romney beat President Obama by 7%. Both political parties know that this district is a toss up, and a good candidate of any party can win here. We are ground zero this year as an electoral battleground.

Southglenn is located in State House District 38. Susan Beckman, a Republican, won in 2016. However, this district voted for Clinton by 3% margin. Republican

While this district doesn't have an election in 2018, it voted for Clinton in 2016 by 7%. Just like with House District 38, Hickenlooper won this district in 2014 while Romney won this district in 2012.

There are only four state house districts that elected Republicans while voting for Clinton and one that voted for Trump while electing a Democrat. Southglenn shares that distinction with the rest of the west side of Centennial (also part of House District 38), along with east Centennial (HD 37), west Arvada (HD 27) and the Jefferson County mountain areas. West Pueblo and its environs holds the distinction of being the only state legislative district to vote for President Trump while electing a Democrat to the state legislature.

Lastly, Southglenn is located in Congressional District 6, represented by Republican Mike Coffman. Clinton won this district by over 30,000 votes in 2016. President Obama won this district by about 18,000 votes in 2012. Governor Hickenlooper won this district in 2014.

On paper, this is one of the most competitive congressional districts in the United States. Look forward to getting inundated with tons of campaign material this fall, not everyone gets to live in a swing district, located in a swing district, located in a swing state.
